#### 7.1.3: Facilities for waste management

Students are more prone to minor injuries, hence the physical education department provides a first aid medical kit. Plaster, cotton gauze, and other kit debris are disposed of alongside non-biodegradable waste.

To guarantee there are no environmental hazards, all e-waste, including computers and their accessories, is gathered and disposed of by the approved vendor. No dangerous chemicals or dyes are utilized in the labs. Chemistry labs employ diluted acids, which are then released straight into the environment.
