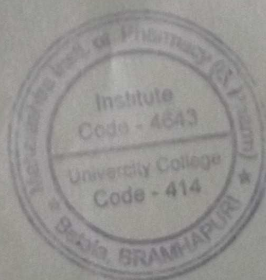



7.1.5: Green campus initiatives include:

Maharashtra Institute of Pharmacy is a quality-conscious college. It protects its environment with its green campus invites and keeps a pollution-free campus. The Green Campus and Environment Policy will develop exciting new co-curricular and extracurricular practices that encourage students and staff to take the lead in creating positive change. These initiatives call for a thorough review of all infrastructural, and administrative functions from the standpoints of energy efficiency, sustainability, and the environment. There are parking spaces for cars at the college's main entrance. With a few exceptions, the campus is car-free, so staff and students feel at ease using the pedestrian-friendly walkways. The campus maintenance committee is in charge of properly maintaining the interior roads, which are bordered by trees and solar lights. Single-use plastic products, including straws, cups, bags, spoons, and bottles, are strictly prohibited, and staff and students are made aware of this through on-site orientation and notice boards. Steel glasses and tea cups have been installed in the canteen to reduce the amount of plastic used. Students and staff are advised to switch from plastic water bottles to copper or steel ones. E-mail and e-messages used for internal campus communication are pushing for a paperless workplace. On campus, electronic notice boards are set up to provide students information and circulars. The official data and information are best sent and stored on electronic devices.

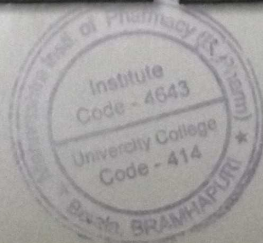
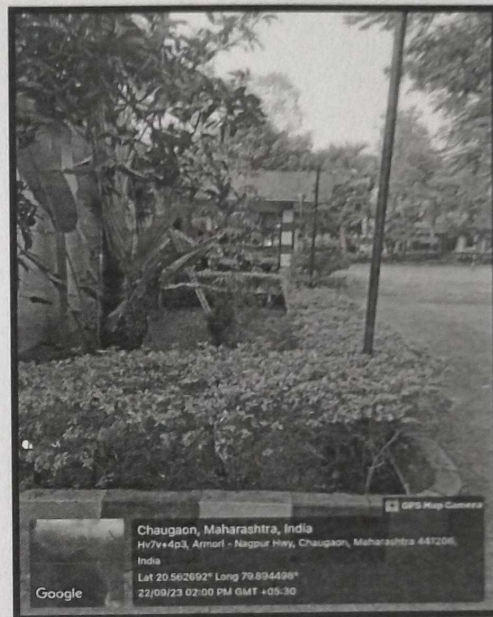
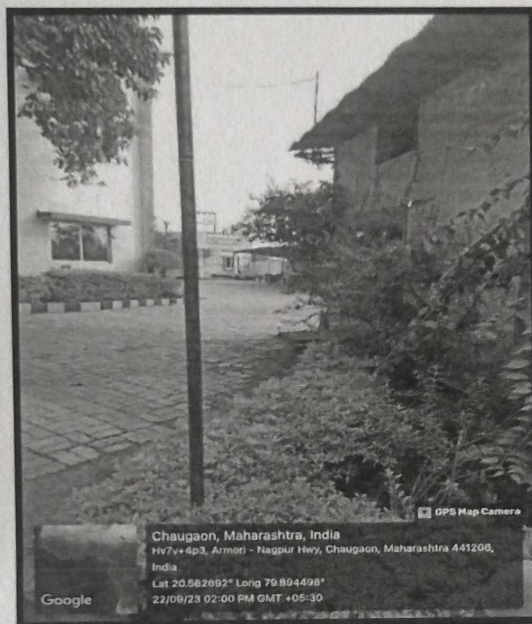
